CATEGORIES OF MEMBERSHIP (Check desired membership)

- Subscribing Membership** - only such persons as are approved by the Board of Directors are eligible for subscribing membership, for example: Architects, Engineers, Building Materials Representatives and other similar persons. Subscribing members shall not have a vote.
- Honorary Membership** - A person meriting the gratitude of the Association may become eligible for honorary membership. An honorary member shall not have a vote.
